**[SECOND REVISED] TRANSMITTAL AFFIDAVIT OF  
MICHAEL J. BARRY PROVIDING LOG OF  
STOCKHOLDER COMMUNICATIONS**

I, Michael J. Barry, do hereby depose and say:

1. I am a Director of Grant & Eisenhofer P.A. (“G&E”), and a member in good standing of the Bar of the Supreme Court of the State of Delaware. G&E is Co-Lead Counsel of record for Plaintiffs in the above-captioned action along with Bernstein Litowitz Berger & Grossman LLP and Fields Kupka & Shukurov LLP. Saxena White P.A. was additional counsel for Plaintiffs. Friedman Oster & Tejtel PLLC was counsel for Plaintiff Allegheny County Employees’ Retirement System.

2. On June 7, 2022, in connection with the filing of Plaintiffs’ Reply Brief in further support of the settlement, I submitted my original Transmittal Affidavit providing a Log of Stockholder Communications received in this action between May 1, 2023 and May 31, 2023, presenting such communications in six separate exhibits.

3. Thereafter, on June 9, 2022, I submitted a Revised Transmittal Affidavit which contained minor edits to the exhibits to reflect duplicate submissions.

4. Since the filing of the Revised Transmittal Affidavit, Plaintiffs' counsel has become aware of some errors to those exhibits. The categories of errors identified include the following:

- a. The stockholder name was spelled incorrectly or did not include the stockholder's full legal name;
- b. The stockholder requested to opt out but was incorrectly placed on the non-opt out list;
- c. The stockholder was miscoded as not providing proof of ownership; or
- d. The stockholder submitted an objection or letter of support but was not included on any list.

5. A small number of these errors was caused by clerical/human error in preparing my Affidavit exhibits. An additional small number of these errors were caused by clerical/human error in the coding process. To the extent Plaintiffs' counsel identified these errors, they were corrected. This Second Revised Transmittal Affidavit contains revisions to the Exhibits in order to correct the errors that were identified. Redline copies of the Exhibits are attached which reflect those changes.

6. In an effort to identify the source of the issue with regard to missing correspondence, Plaintiffs' counsel performed an additional series of audits of the objections e-mail mailbox and objections received. As part of that process, we identified the issue. When saving stockholder communications for export to the objection review platform, files were overwriting each other where they shared

similar or identical subject lines and/or were not saving where there was a particularly long or complicated email subject. Upon learning of the source of the issue, Plaintiffs' counsel exported e-mails sent to the AMC Settlement Objections in a pst file format, which resolved the overwriting and naming convention issue. This resulted in the addition of approximately 312 names, which are set forth in the appropriate categories as Exhibits A1 through F1. This issue does not appear to have impacted the submission of these objections to the Special Master as they were received and has now been resolved.

7. Exhibit A is a revised index of Objections that were submitted with proof of ownership and which *requested opt-out* from the settlement. Exhibit A was revised to account for duplicate submissions that were intentionally omitted from the files produced.

8. Exhibit B is a revised index of Objections that were submitted with proof of ownership and which *did not request opt-out* from the settlement. Exhibit B was revised to account for duplicate submissions that were intentionally omitted from the files produced.

9. Exhibit C is a revised index of Statements of Support for the settlement that were submitted with proof of ownership. Exhibit C did not require any revisions.

10. Exhibit D is a revised index of stockholder communications raising concerns regarding the postcard notice and/or non-compliant Objections that were submitted without any proof of ownership AND which *requested opt-out* from the settlement. Exhibit D did not require any revisions.

11. Exhibit E is a revised index of stockholder communications complaining about lack of postcard notice and/or non-compliant Objections that were submitted without any proof of ownership AND which *did not request opt-out* from the settlement. Exhibit E was revised to account for duplicate submissions that were intentionally omitted from the files produced.


12. Exhibit F is a revised index of non-compliant Statements of Support for the settlement that were submitted without any proof of ownership. Exhibit F was revised to account for duplicate submissions that were intentionally omitted from the files produced.

13. Additionally, Plaintiffs' counsel has received 93 emails from stockholders who previously submitted timely objections to the settlement but did not explicitly indicate a desire to opt out of any potential settlement, if permitted to do so, but want to do so now. Exhibit G is a list of those stockholders.

I declare under penalty of perjury under the laws of Delaware that the foregoing is true and correct.
